## I. SCOPE OF WORK:

The Department of Conservation and Natural Resources, Bureau of State Parks, Pymatuning State Park requires a vendor to furnish and deliver an EZ-Dock Manufactured ADA Pass Through Kayak Dock System.

## II. CONTRACT REQUIREMENTS:

Furnish one (1) EZ-DOCK ADA Pass Through Kayak Launch Dock System (206030PW-EZ) that meet or exceed the Specifications listed below:

## III. DELIVERY

- 1. If the awarded vendor is located within a 200 miles radius of the Pymatuning State Park, 2660 Williamsfield Road, Jamestown, PA 16134-3560, Pymatuning State Park will pick up the dock accordingly at the vendor's requested location. If this is applicable, the vendor should not input shipping charges on Line 37 of their Bid Response.
- 2. If the awarded vendor is located outside of a 200-mile radius of Pymatuning State Park, the vendor is responsible for delivery to:

If this is applicable, the vendor must input appropriate shipping charges on Line 27 of their Bid Response.

If delivery is required, bid price must include all shipping, transportation, environmental handling, unloading charges, and any other associated charges for delivery.

Prior arrangements must be made by coordinated with Dan Bickel, Park Manager, 724-932-3141 x 102 at least one (1) week prior to arrival.

## IV. CONTRACT REQUIREMENTS:

All products manufactured in the United States are warranted against product failure from normal use or defects for 8 years, accessories 1 year

The contractor agrees to comply with the Reciprocal Limitations Act and the Steel Products Procurement Act as attached.

## V. CONTRACT TERM:

The contract shall commence upon execution and receipt of purchase order and will terminate March 31, 2020.

## VI. BID AWARD:

Bidder must complete and return the following:

- The electronic Invitation for Bid to be found at www.pasupplierportal.state.pa.us.
- 2. A properly executed Reciprocal Limitations Act form that lists the state of manufacture for any supplies procured.

The unit price shall include all labor, materials, equipment, tools, insurance, and all items necessary for completion of the project.

The bid will be awarded based on the total sum of all blocks as indicated on the IFB-Invitation for Bids.

Please note that the Department will only accept out to two (2) decimal points when entering your pricing.

#### VII. PAYMENT TERMS:

Payment shall be made upon satisfactory completion of contract.

## VIII. INVOICES:

Invoice format shall be in accordance with the IFB – Invitation for Bid.

#### IX. RECEIPT AND OPENING OF BIDS:
