The personnel that operate out of this building are frequently in the field; please leave a message and your call will be returned. The project area is open to public travel. Permission is not required to visit the site; however, we recommend contacting Mr. Erdman or Mr. Sneath for directions and for status of road conditions before going to the site.

Attached to the project listing in electronic format are Terms and Conditions of Project, Conditions for Construction Contracts and Technical Specifications (Sections 1 through 13). Three drawings titled "Cherry Run Road Maintenance Project" are also attached. All bids must be submitted electronically using the SRM system and must be submitted by 2:00PM on September 13, 2023.
