

# STATEMENT OF WORK INVITATION FOR BID (IFB)

1. **SCOPE/OVERVIEW:**

This Invitation for Bid (IFB) issued by the Commonwealth of Pennsylvania Department of Transportation's (PennDOT) Bureau of Office Services shall provide a quote for Wet Reflective Temporary Pavement Marking Tape that will result in a onetime purchase order for these materials.

2. **WORKER PROTECTION AND INVESTMENT CERTIFICATION:**

Pursuant to [Executive Order 2021-06: Worker Protection and Investment](#), signed into law on October 21, 2021, the Commonwealth is responsible for ensuring that every Pennsylvania worker has a safe and healthy work environment and the protections afforded them through labor laws. To that end, contractors and grantees of the Commonwealth must certify that they are in compliance with all applicable Pennsylvania state labor and workforce safety laws. Such certification shall be made through the Worker Protection and Investment Certification Form ([BOP-2201](#)) and submitted with the bid, proposal, or quote. Refer to **Attachment A – Worker Protection and Investment Certification** for further information.

3. **REJECTION OF BIDS:**

The Issuing Office reserves the right to reject any and all Bids, to waive technical defects or any informality in Bids, and to accept or reject any part of any Bid if the best interests of the Commonwealth are thereby served.

4. **TIE BIDS:**

All tie bids will be broken by the Issuing Office.

5. **AWARD:**

This bid will be awarded to the lowest responsive and responsible bidder. This bid solicitation has been reserved for Small Business Contracting. Only those Bidders certified as DGS Small Businesses through the Small Business Contracting Program may submit a bid for these services. Unless all Bids are rejected, and except as otherwise provided by law, award will be made through the issuance of a contract/purchase order in accordance with the method of award. As a condition for receipt of award of a contract/purchase order, the Bidder must be registered in the Commonwealth of Pennsylvania's Vendor Master file. 6. **PROMPT PAYMENT DISCOUNTS:**

Prompt payment discounts will not be considered in making an award. If prompt payment discounts are offered by any Bidder, however, the Issuing Office will take advantage of such offer.

The Wet Reflective Temporary Pavement Marking Tape shall meet the following specifications:
