The following change has been made to the solicitation:

Appendix H, Cost Matrix --- additional lines were added to Proposed Hardware and Proposed Software Tabs to allow for more entries; On the DELIVERABLES tab, under REPORTS AND CONTROL --all lines were made accessible to allow the offeror to enter costs for any year.

Appendix M, System Metrics --- added statistics for paper certifications, employer count and wage items to the System Statistics for 2014 tab.

Appendix N, Glossary --- The definition of "conscience money" was revised.

Appendix V, Technical and Non-Functional Requirements --- added a requirement to the Solution Requirements tab for State Directory of New Hires.

Appendix HH, Interfaces --- revised the information re: State Directory of New Hires.

There have been revisions to the RFP with a short overview of the change in the following sections.

IV-3.7.1 – Requirements = Added #4 under Bullet A

IV-3.10.1 – Requirements = Added letter F.

IV-3.14 – Disaster Recovery – modified Section heading to read "Offeror Disaster Recovery".

IV-3.14.1 - Requirements = Modified Letter A and B.

IV-3.14.2 – Offeror Response = Modified Letter A and eliminated letter B.

IV-4.11.4 – Work Products = Added the Letter "A".

IV-4.12 – Solution Disaster Recovery = This is a new Section that was inserted here.

IV- 4.13 – Outgoing Transition and Turnover = New Section (old section IV-4.12 moved to IV-4.13).
