Suppliers who do not own an approved manufacturing source must furnish with their bids a Manufacturer's Guarantee (Attachment A) signed by an authorized signatory of the approved source of the Bulletin 15 materials. Failure to include a signed guarantee with the ITQ shall result in the rejection of the ITQ until such time as the Manufactures Guarantee is provided or the bidder offers to provide material from an approved source they own.

Attachment A and the State of Manufacture Form is now part of this solicitation – please complete and return these with other documents listed with this solicitation.

- Attach this Addendum to your solicitation response. Failure to do so may result in disqualification.
