12	Various	Various	Various	We are seeking clarification regarding the DB inclusion provisions of the RFP.  In I-5 Type of Contract, the RFP states that the Commission intends to select two firms, a "Financial Advisor" and a "Co-Financial Advisor" and its goal is that at least one of the selected firms is a DB. The RFP also states in the section, that "In order to encourage enhanced DB inclusion, the Commission's Criteria for Selection for this RFP will place particular emphasis on the level of DB inclusion." In II-2 Diverse Business (DB) Requirements, the section strongly encourages DB firms to respond individually, but a few sentences later encourages non-DB primes to utilize DB subconsultants and that such use may be considered as a significant factor in the selection. In III-3 Proposal Evaluation, the RFP also states that additional factors would include "diversity inclusion." And in III-4 Evaluation Criteria 2.  Commitment to Diversity and Inclusion the paragraph states again that "DB firms are strongly encouraged to respond individually as a firm" and that "the utilization of DB sub consultants by non-DB primes are strongly encouraged and will be considered a significant criterion in the evaluation of proposals and may be considered as a significant factor in the Commission's selection of two firms for this contract." And in I-8 Subcontracting, it states that a firm which responds as a prime, which DB firms are encouraged to do, may not be included as a designated sub consultant.  The various sections seem to be in conflict, and we would like clarification on how a non-DB prime manages these elements to provide a response that meets the Commission's goals.	The RFP does not establish "Minimum Participation Levels" for Diverse Business participation as sub-contractors but rather encourages non-DB prime respondents to utilize DB firms as sub-contractors to potentially increase their (prime respondents) rating during the evaluation process. Additionally, the Commission increased the "Commitment to Diversity" evaluation criteria to its second highest consideration to increase its relative importance and encourage non-DB respondents to consider utilizing DB firms as sub-contractors. DB firms are encouraged to submit as a prime respondent but are not required to do so. DB firms who do NOT choose to submit as a prime are eligible to be part of other prime respondents' teams. See Appendix F – Diverse Business Requirements – particularly section (c).1.b. – "Actions required by proposer during the procurement/consultant selection phase."
