Questions and Answers

- Q1. What are the business drivers that are influencing the decision to maintain a separate ordering platform for same day delivery?
- **A1.** PLCB is currently concentrating on a complete site redesign and platform upgrade of its e-commerce platform (<u>www.finewineandgoodspirits.com</u>). The current site is not mobile-friendly and therefore not PLCB's best option for offering Same Day Delivery Services at this time.

PLCB believes that utilizing a third-party ordering platform is the best option available to bring Same Day Delivery to Pennsylvania consumers in the shorter term.

- Q2. Is enabling same day delivery off existing (http://www.finewineandgoodspirits.com) an option or of interest to PLCB?
 - **A2.** See answer to Q1. Also, per Section III-5(E), PLCB welcomes ideas and suggestions for integrating with www.finewineandgoodspirits.com.
- Q3. Is it possible to submit a joint proposal with a logistics company?
- **A3.** Offerors may partner or subcontract with any other business as they see fit; however, the PLCB will only enter into one contract with a <u>single entity</u> as a result of this RFP. Proposals must meet all of the requirements of Section I-11 to be considered by the evaluation committee. Please also note Section I-15 regarding responsibilities of prime contractors.
