 - b. **To**: The proposal should not be more than 200 pages.
- 3. Changes the Calendar of Events, specifically the Proposal Due Date and Time as follows:

From: 11/20/2014 no later than 2:00 pm **To:** 11/25/2014 no later than 2:00 pm

- 4. <u>Deletes</u> Appendix E Cost Submittal FINAL 10.02.14 in its entirety and <u>replaces</u> it with Appendix E Cost Submittal FINAL 11.5.14.
- 5. **Changes** the Contract Term as follows:

From: 78 month contract term with a 42 month renewal

<u>To:</u> The term of the contract will commence on the Effective Date of the fully executed Contract and will end on July 26, 2021. The Issuing Office will fix the Effective Date after the contract has been fully executed by the selected Offeror and by the Commonwealth and all approvals required by Commonwealth contracting procedures have been obtained. The selected Offeror shall not start the performance of any work prior to the Effective Date of the contract and the Commonwealth shall not be liable to pay the selected Offeror for any service or work performed or expenses incurred before the Effective Date of the contract.

The Commonwealth's Contracting Officer may renew this contract upon the same terms and conditions, incrementally or in one-step, for a time period not to exceed a total of 120 months (i.e. 10 years), which includes the initial contract term, by written notification to the selected Offeror by the Contracting Officer. Renewal of this contract may require review and approval as required by Commonwealth contracting procedures. Any renewal will be under the same terms and conditions.

The cost for the renewal submitted by the selected Offeror and approved by PennDOT for contract award may be negotiated for an increase up to a maximum of 2.5% during each renewal term.

Except as clarified and amended by this Addendum, the terms, conditions, specifications, and instructions of the solicitation and any previous Addendum(s), remain as originally written.
