1. The Motorcycle Safety Foundation (MSF) Basic Rider Course (BRCu) uses an eCourse for the classroom portion of the course, this is the same format that is used by 47 other states. My question is, will this be accepted by Pennsylvania as well?
 - a. Yes, the MSF BRCu eCourse will be accepted.
2. How does the submission of a proposal work?

3. Can a list of the motorcycle safety centers in Pennsylvania be provided?
 - a. Please see Appendix G.
4. How should offerors contact PennDOT owned sites?
 - a. All proposals for PennDOT owned sites are on a "first come first served basis." When a proposal is received for any PennDOT owned site, tracking and coordination will be made by the Issuing Officer.
