A SOW is not required for standard maintenance and support (i.e. Cisco Smartnet), but the service level must be described on the quote and attached to the associated purchase order.

Orders for maintenance/extended warranty services made during the term of the contract may extend up to three (3) years past the expiration date of the contract.
