At that time our company opened the document and saw the pricing submitted by our company along with the other bidders. How can the Commonwealth reissue the solicitation as IFB #6100030323 on 7/24/14 and be able to fairly assess the low bidder when pricing	<ul> <li>1a. Under the Procurement Code, 62 Pa.C.S. §521, the Commonwealth has the right to cancel a solicitation. The Commonwealth is not precluded from re-issuing a solicitation.</li> <li>1b. The purpose of Paragraphs B and C of I.16 Submission-001.1 Representations and Authorizations (Oct 2013) is to require a bidder to acknowledge that it has not engaged in unlawful bid-rigging and collusion with other bidders. Bid-rigging is defined in Part I, Chapter 40 of the Procurement Handbook as "the concerted activity of two or more persons to determine in advance the winning bidder of a contract let or to be let for a government agency." A bidder can arrive at its bid independently as long as it does not engage in collusion, bid-rigging or other prohibited activities with other bidders. Refer to Procurement Handbook, Part I, Chapter 40. For this IFB, each bidder must come to a price based on its own business model. The bid tabulation that was posted with the prior canceled IFB contained different requirements then those listed with this IFB, and therefore, the price may be different.</li> </ul>
2			was disclosed for the exact same services? In the In the original IFB document, there were volume and experience requirements listed for Lot #1; however, there were no such requirements for the paternity testing portion (Lot #2). In the reissued IFB, there are still no such requirements. Since the award will be decided on price only, how will the Commonwealth assess the capabilities of the chosen laboratory in order to ensure that laboratory has a proven track record and is experienced in handling large testing volumes?	This solicitation is an IFB which will be awarded to the lowest responsive and responsible bidder.
3			Please consider the following scenario: What if a bidder were to submit \$10.00 for the vendor-collection all other counties price category and \$50.00 per sample for all of the remaining categories. This vendor is awarded the contract as low bidder, yet clearly there is no value to the Commonwealth. In fact, the Commonwealth would in theory be paying a substantial amount more than it is currently paying for these services. Would it be more prudent for the Commonwealth to consider assigning actual proposed testing volumes to each pricing category based on historical data so that a total figure could be calculated as an annual expense? By approaching the bid in this manner, the evaluation of the pricing would be reflective of actual expenses and the Commonwealth would get the best value.
