#### STATEMENT OF WORK

# FURNISH FLOATING DOCK MATERIALS YELLOW CREEK STATE PARK INDIANA COUNTY

### I. SCOPE OF WORK:

The Department of Conservation and Natural Resources, Bureau of State Parks, requires the services of a contractor to furnish floating dock materials to Yellow Creek State Park, 170 Route 259 Highway, Penn Run, PA 15765-5941 (Indiana County).

## II. CONTRACT TASKS:

The tasks to be completed in the performance of this contract are as follows:

- 1. Furnish all loose materials necessary for the construction and installation of a floating wood dock system, ramps, and connection materials to the bulkhead as specified in the attached Technical Specifications and General Dock Details.
- 2. The intent is to purchase all loose materials necessary for the construction of the floating wood dock systems. Assembly of dock sections themselves will be the responsibility of the Department.

# **III. CONTRACTOR REFERENCES:**

After the bid opening, and prior to awarding of the contract, the Department has the right to request references (names, addresses, and telephone numbers) of similar work performed in the previous two (2) years as proof of qualifications to perform the work involved in this contract.

#### IV. SITE INSPECTION:

## V. CONTRACT REQUIREMENTS:

The contractor agrees to comply with all attachments to this contract as referenced in the Invitation for Bid (IFB) and attached to this Statement of Work.

Invoice format shall be in accordance with the Invitation for Bid (IFB).

### VI. DELIVERY:

Delivery shall commence upon execution and receipt of purchase order and terminate on May 1, 2015.

The specific delivery location is to Camp Seth Mack within Yellow Creek State Park. Contractor shall contact James Tweardy at 724-357-7903 prior to delivery of materials to discuss specifics.

#### VII. BID AWARD:

The bidder shall complete the electronic **Invitation for Bid to be found at**<u>www.pasupplierportal.state.pa.us</u>
and complete and attach the following to the electronic Invitation for Bid for award of the bid:

# a. Pages 3 and 4 of the Reciprocal Limitations Act Form

Bid will be awarded based on lowest total sum. In the event of a discrepancy between the unit price and extension of figures, the unit price will prevail.

The Department will only accept out to two (2) decimal points when entering your "Unit Price" figures in the Invitation for Bid.

#### **VIII. PAYMENT TERMS:**

Payment shall be made upon satisfactory completion of contract.
