RFQ Revisions

2. **Adds** a sentence to Section I-4, *Problem Statement*, The Commonwealth reserves the right to include within this contract work to maintain, enhance, and support the applications of other Commonwealth agencies.
3. **Removes** Section I-28, *Disadvantaged Business Enterprise (DBE) Involvement*, paragraph 1, in its entirety and **replaces** it with the following:

The Commonwealth of Pennsylvania is committed to providing opportunities for Disadvantaged Business Enterprises to compete for work. To support this commitment, there is a goal of 12% of the total contract dollar amount set for this RFP.

4. **Removes** Section II-6, *Personnel*, 2. One (1) Resume for each Key and Primary personnel that is no more than 2 total numbered pages. **Replaces** it with the following:
 2. One (1) Resume for each Key and Primary personnel that is no more than two (2) total numbered pages. Resumes for Primary personnel are optional.
5. **Removes** Section III-4, *Contractor Responsibility*, B. remove in its entirety and **replaces** it with the following:

B. The Contractor's financial information must demonstrate that the Contractor possesses the financial capability to assure good faith performance of the contract. The Issuing Office will review the Contractor's previous two (2) financial statements, any additional information received from the Contractor, and any other publicly-available financial information concerning the Contractor. The Issuing Office will then assess each Contractor's financial capacity based on financial ratios, industry standards, and trends.

5. **Removes** Section IV-4 – Task E, paragraph 2, there is no guarantee that Task D will be used by PennDOT. **Replaces** it with, There is no guarantee that Task E will be used by PennDOT.
6. **Removes** RFQ – 6100038014 – revised 12.8.16.pdf in its entirety and **replaces** it with RFQ – 6100038014 – revised 1-18-17.
7. **Removes** Appendix C – Cost Submittal Final in its entirety, and **replaces** it with Appendix C – Cost Submittal – Revised 1-18-17.

Except as clarified and amended by this Addendum, the terms, conditions, specifications, and instructions of the solicitation and any previous Addendum(s), remain as originally written.
