### General Requirements for all Items:

### **Header Text**

Vendor shall fabricate and deliver the fencing materials to the State Correctional Institution at Rockview, Bellefonte, Centre County.

When quoting the panels, all hardware including hinges, latches, tension bars, braces, and ties must be included.

The Reciprocal Limitations Act form GSPUR89 must be completed and reattached to the electronic bid before submittal.

A MANDATORY SITE VISIT must be scheduled through the Facilities Maintenance Manager, Michael Wenrick at (814)355-4874, ext. 324 or 219. It is the responsibility of the contractor, by careful personal examination, to satisfy himself as to the nature and location of the work, the conformation of the ground, and the character, quality, and quantity of the materials that will be required. Failure of the contractor to visit the site, recognize, take into account and include in his bid, site conditions not indicated in these specifications that will affect his work, shall not be considered cause for increase in contract cost. Prices must be firm and inclusive of all costs associated with arrival on site, materials and tools required. The certification form Proof of Site Visit must be completed and returned with bid submission.

Common carriers will not be required to render clearance checks, however are subject to search and escort procedures. ALL CARRIERS reporting to outside warehouses must secure their vehicle (windows closed and doors locked), sign in at warehouse and wait for further directions from correctional staff.

No vehicle is to be on facility grounds with the engine running without the operator present and in control of the vehicle. This applies to all employees, visitors, contractors, and vendors. Additionally, the use of automatic vehicle starters is prohibited on state grounds. Anyone found in violation of this prohibition will be subject to loss of access to the facility. If the engine of an Emergency Services vehicle must remain running, a Corrections Officer shall stay with the vehicle at all times.
