- 1. Are you all able to ship the trade in weapons to us if we pay for freight and provide a shipping label or do they have to be picked up in person?
  - Winning bidder may pick up the weapons or provide prepaid shipping labels. If shipping labels are provided insurance in the amount of trade in price must be purchased.
- 2. The lead time on the bid is 90 days for delivery, these are class III items so they can take up to 6 months including ATF approval, is 90 days firm?
  - This can be extended to 180 days.
- 3. I noticed on the Specifications portion that it now says Noveske KX5 Flash Suppressor when it previously did not on the first bid that was put out. That item does not come with the Colt and has to be ordered separately elsewhere. We however do not carry that manufacturer, can we no bid on that specific item?
  - This is a no substitute bid for the rifles and listed accessories. Additionally the
    unit price for each new rifle, shall include the rifle as specified under paragraph
    A, and the accessories specified under paragraph B of the specifications.
