DELIVERY

If awarded vendor is within a 200 mile radius of Shawnee State Park, 132 State Park Road, Schellsburg PA 15559 (Bedford County) Park Maintenance Supervisor will coordinate pick with awarded vendor using Registered Dealer License Plate provided by Region 3 State Park Office.

If awarded vendor location exceeds 200 mile radius of the park, vendor shall include all delivery costs within his/her quote for FOB delivery to Shawnee State Park (Bedford County), 132 State Park Road, Schellsburg PA 15559. These costs shall include all shipping, transportation, environmental handling, unloading charges, and any other associated charges required to make delivery. Vendor shall contact Park Maintenance Supervisor, Jim Miller by telephone 814-733-4895 between the hours of 7:15 am – 2:30 pm; Monday through Friday to coordinate delivery.

OWNER’S MANUALS WITH WARRANTY INFORMATION FOR BOAT, MOTOR AND TRAILER SHALL BE PROVIDED UPON DELIVERY.

An individual Manufacturer's Certificate of Origin shall be provided from awarded vendor for each item at the time of pickup or delivery. These individual documents shall include VIN#, Year, Make, Model and Serial # for each unit as well as weight rating/s, if applicable. THE FOLLOWING INFORMATION MUST BE ADDED ALONG WITH THE DEALER'S NOTARIZED SEAL UNDER THE FIRST ASSIGNMENT ON THE REVERSE SIDE OF EACH CERTIFICATE OF ORIGIN: Pennsylvania Department of General Services; 2221 Forster Street; Harrisburg PA 17125.

V. Iran Free Procurement Certification & Disclosure

Prior to entering a contract worth at least \$1,000,000 or more with a Commonwealth entity, a bidder must: a) certify it is not on the current list of persons engaged in investment activities in Iran created by the Pennsylvania Department of General Services (“DGS”) pursuant to Section 3503 of the Procurement Code and is eligible to contract with the Commonwealth under Sections 3501-3506 of the Procurement Code; or b) demonstrate it has received an exception from the certification requirement for that solicitation or contract pursuant to Section 3503(e).
