QUESTIONS:

All questions must be submitted before the close of business on December 28, 2017. Any question submitted after that date will be answer at the discretion of the Commonwealth.

AWARDS:

Category 1

PA-DOT Spec'ed Units: This is a multiple-award action to be awarded on an OEM's stainless-steel spreaders by model basis with award being made to the low responsive, responsible bidder for any given OEM's (Original Equipment Manufacturer) model offered. All bidders to list their offerings in accordance to Tab Sheet #2 of the spreadsheet workbook (PA-DOT Spec'ed Units).

Category 2

Other Spreaders and Parts: This is a multiple-award action to be awarded on a multiple award basis. Multiple award meaning that all Original Equipment Manufacturer's (OEM's) salt spreader equipment, in accordance with Bid Item Sheet listings, may be awarded. However, only a maximum of one award will be made representing any given OEM's salt spreader equipment (to include maintenance & repair parts) All bidders to list their offerings in accordance to Tab Sheet #3 (Other Spreaders and Parts) of the spreadsheet workbook.

SPECIFICATIONS:

For this IFB, the items have been divided into two (2) categories. A bidder may bid on one (1) or both of the following categories:

Category 1 – PA-DOT Spec'ed Units – this category is a list of products that currently represent the most frequently used items and the majority of PA-DOT's annual spend on stainless steel salt spreader units. The Commonwealth reserves the right to add new items to this category. If new items are added to this category, pricing will be negotiated.

Category 2 – All Other Salt Spreader Units and Maintenance & Repair Parts (Discounted from OEM List Pricing) – this category will be at a percentage (%) discount off OEM's most current yearly price list and stock catalog.

MANUALS:

WARRANTY:

The vendor will replace, free of charge within one (1) year from date of sale, any spreader (including spinner and auger motors and sensors) which in the judgment of the manufacturer has failed because of defective material or workmanship, provided it is shown to be properly mounted, and not subject to abuse in operation or assembly.

The successful bidder shall be an authorized dealer for the proposed spreader/s and shall comply with the manufacturer's warranty or authorize a qualified dealer in the locality in which the unit is assigned, to do whatever is required to comply with the manufacturer's warranty without cost to the ordering entity.

DELIVERY:

The contractor must deliver all units within <u>Thirty (30) calendar days</u> after receipt of a purchase order, issued against the contract. It shall be assumed by all parties that the contractor received the purchase order on the third business day following the day on the purchase order, unless the contractor provides credible evidence that the order was received on a later date.

SHIPPING:

Shall be in accordance with normal industry standards and at FOB Destination terms.

MINIMUM ORDER:

The minimum order qualifying for F.O.B. Destination delivered prices shall be one (1) unit. (It is understood that prices bid & awarded are at FOB Destination delivered pricing that includes all delivery, and shipping & handling charges to the Commonwealth's ordering entity's location, as stated in the Purchase Order).

COSTARS DELIVERY FEE:
