Bids will be opened electronically and read in the Division of Contracts and Procurement, 2001 Elmerton Avenue, Harrisburg, PA 17110-9797, on March 2, 2018 at 2:00 PM.

## When bidding, amount bid should be in dollars and cents----no fractions of a cent will be accepted. The HVAC, Electric and Plumbing line items are to be considered separate bids and awarded as such. The other line items will be awarded to the "General" Contractor.
