All plumbing, lighting and electric and installation of a HVAC system are to be bid separate from this contract. When bidding, amount bid should be in dollars and cents-----no fractions of a cent will be accepted. The HVAC, Electric and Plumbing line items are to be considered separate bids and awarded as such for PGC-245-18-03. All of the line items in this contract will be awarded to the "General" Contractor with the overall low bid.
