The Pennsylvania Game Commission (PGC) is soliciting electronic bids for the demolition of a storage building (SB #177) at the Loyalsock Game Farm in Eldred Township, Lycoming County. The storage building is a 2-story wood frame, metal sided structure with full poured concrete floor slab measuring 40-feet by 80-feet. The scope of the project includes demolition of the building, disposal of the building remains and disposal of interior items. The concrete floor slab and foundation are to remain. Bids will be publicly opened and read in the PGC Division of Contracts and Procurement, 2001 Elmerton Avenue, Harrisburg, PA 17110-9797, on Wednesday, October 17, 2018 at 2:00 PM.

**When bidding, amount bid should be in dollars and cents-----no fractions of a cent will be accepted.**

Questions concerning project specifications and requirements should be directed to Foster Schaffer or Jim Mercer at 717-787-9620. Any questions concerning completion of the electronic bid should be directed to PGC-Contracts and Procurement Division at 717-787-6594.

Bidders should visit the site to ascertain the pertinent conditions such as access, site contours, proximity of utilities, structural characteristics of the building and vegetation in the work area. Contact Brad Stine, Superintendent-Loyalsock Game Farm at 570-435-2043 for directions to the site and to make arrangements to visit the site. This phone number is for the office at the game farm. A location map is included on the drawing. The building to be demolished is located off a paved road. This area is restricted and is not open to the public. Prior permission to view the site is required.

Attached to the electronic project listing are Terms and Conditions of Project, Conditions for Construction Contracts and Technical Specifications (Sections 1 through 3). A drawing titled "Building Demolition – Storage Building (SB #177)" is also attached. These enclosures are part of the bid. All bids must be submitted electronically using the SRM system. Bids must be received by 2:00 PM on October 17, 2018. A bid guarantee or bond is not required.

The Commonwealth reserves the right to reject any and all bids, to waive technical defects in bids and to accept or reject any part of the bid deemed in the best interests of the Commonwealth. Except as otherwise provided by law, award will be made to the lowest responsible and responsive bidder. A Purchase Order will be generated at the time of award

without further input from the successful bidder. Awarded vendor will be sent a copy of this document and no work will be authorized until the vendor is in receipt of the Purchase Order.

All vendors who conduct business with the Pennsylvania Game Commission must have a Vendor No. assigned to them in order to receive payment from the Commonwealth.
