*List any and all changes:*

*Line item 14: Change Item Text to: “frozen chicken breast, fillet, boneless, breaded. IQF. Heat and serve. Pre-browned. Breading not to exceed a maximum of 25% pick up of the uncooked product weight. Portion size: 4 oz. Mechanically ground, reformed or shaped, chicken is not acceptable. Natural, whole muscle shape. Layered or stack packed in moisture/vapor-proof carton or placed in polybags with tops securely wrapped/closed. 5 to 10 # units.*

*Line item 18: Change Item Text to: “frozen chicken breaded fried oven easy, cooked 8pc., super chicken, bulk. NO HONEY. Brands: Pierce=Super Chicken or Tyson breaded chicken 8 piece”*

*Line item 23: Change Item Text to: “Smith Brand wieners skinless 8/1#-10# case. 180% beef 20% pork, no poultry less non fat milk won’t shrink on grill natural smoked, case yields approximately 80 wieners, frozen”*

*Line item 24: Change Item Text to: “Smith Brand bologna, all meat - 60% beef, 40% pork, no poultry, 11 grams of fat per 55 gram serving, great for frying, 4/6#, frozen”*

*Line item 45: Change Item Text to: “, Smith Brand Ox Roast, frozen sliced ox roast beef in broth, 4/5# case”*

*Line item 137: Change Item Text to: “frozen egg, turkey sausage, potato and cheese breakfast burrito wrapped in a tortilla, 3.5oz, 90 per case, heat and serve”*
