## To All Suppliers:

The Commonwealth of Pennsylvania defines a solicitation "Addendum" as an addition to or amendment of the original terms, conditions, specifications, or instructions of a procurement solicitation (e.g., Invitation for Bids or Request for Proposals).

## Please note the following (4) as part of this Solicitation:

- 1) Revised Bid Submission deadline: Extended to February 7, 2019 at 2:30 PM EST
- 2) Attachment B Bid Sheet: Line Items 3A (pounds) and 3B (gallons) for 50% Hydrogen Peroxide, Technical Grade is being requested by the PA Department of Environmental Protection (DEP) for an annual <u>estimated</u> quantity of 418,000 pounds. Some delivery locations require a 19,960 lb. minimum (equal to 2,000 gallons) others may require a full load of between 39,920 to 44,910 lbs. (equal to 4,000 to 4,500 gallons) and may include deliveries to Cambria, Elk, Allegheny and Indiana counties.
  - Interested bidders should list their pricing, minimum delivery and county coverage they are offering on Attachment B- Bid Sheet. *Please note any Commonwealth (state) agency may use this chemical as part of this solicitation/contract*.
- 3) Attachment B Bid Sheet: Line 53B for Ferri+Plus 1000 Series is being requested by the PA Department of Corrections (DOC) in Cumberland County for an annual <u>estimated</u> usage of 100,000 lbs. in 330-gallon totes (3,800 lb. totes). Please note awarded vendor(s) are responsible to deliver and unload each tote into DOCs chemical storage tank.
  - Interested bidders should list their pricing, minimum delivery and county coverage they are offering on Attachment B- Bid Sheet. *In addition, any Commonwealth (state) agency may use this chemical as part of this solicitation/contract*.

4) PCID 1165 for *Anionic Polyacrylamide Flocculate* and the specification for *Ferri+Plus 1000 Series* should include the statement "Shall be ANSI/NSF 60 compliant". PCID 1166 for 50% Hydrogen *Peroxide, Technical Grade* does not require this statement.
