The Pennsylvania Game Commission is soliciting bids for the HVAC, Electrical and Plumbing for the new Crew Headquarters Building on State Game Lands #073. The scope of the project has been separated by three bids in addition to the General Contactor. These include the HVAC system, Electrical and lighting and also all plumbing for a 32' x 64' pole building. Bids will be opened electronically and read in the Division of Contracts and Procurement, 2001 Elmerton Avenue, Harrisburg, PA 17110-9797, on **April 17, 2019 at 2:00 PM.**

**When bidding, bid amount should be in dollars and cents-----no fractions of a cent will be accepted. The HVAC, Electric and Plumbing line items are to be considered separate bids and awarded as such for PGC-073-18-02.**

Questions concerning project specifications and requirements should be directed to Jim Mercer or Foster Schaffer or at 717-787-9620. Any questions concerning completion of the Electronic Proposal Form should call the Division of Contracts and Procurement at 717-787-6594.

Bidders should visit the site to ascertain the pertinent conditions such as access, site contours, proximity of utilities, structural characteristics of the buildings and general site conditions in the work area. Please contact Chris Skipper, PGC South Central Region Group 1 Land Manager at 814-643-1831 for directions and to make arrangements to visit the site. The phone number is for the Game Commission's Southcentral Regional Office (SCRO) in Huntingdon, PA. The dispatchers at the SCRO will contact Mr. Skipper on behalf of interested bidders. An alternate contact is Game Lands Maintenance Supervisor Terry Horton. To contact Mr. Horton, please call the PGC Blair County maintenance building at 814-793-2070. The personnel that work in this building are frequently out in the field so please leave a message. A location map is included on the drawing. This area is not restricted but bidders interested in viewing the site should contact Mr. Skipper or Mr. Horton to get proper directions and permission to enter on to PGC property.

Enclosed are the Project and Conditions for Construction Contracts and Technical Specifications (Sections 17 through 19). Five drawings are also enclosed entitled "State Game Lands #073, North Woodbury Township, Blair County". All bids must be submitted electronically using the SRM system. ***Bids must be submitted before the deadline of 2:00 PM on April 17, 2018 to be eligible for consideration.***

The Commonwealth reserves the right to reject any and all bids, to waive technical defects in bids and to accept or reject any part of the bid deemed in the best interests of the Commonwealth.

Except as otherwise provided by law, award will be made to the lowest responsible and responsive bidder. A Purchase Order will be generated at the time of award without further input from the successful bidder. Awarded vendor will be sent a copy of this document and no work will be authorized until the vendor is in receipt of the Purchase Order.

All vendors who conduct business with the Pennsylvania Game Commission must have a Vendor No. assigned to them in order to receive payment from the Commonwealth.
