The Pennsylvania Game Commission (PGC) is soliciting electronic bids for the demolition of a small building on State Game Lands (SGL) #38 in Jackson Township, Monroe County. The building is a 1-story concrete block structure inside a chain link fence enclosure. The scope of the project includes demolition of the building, disposal of the building remains, disposal of interior items, removal of the chain link fence and filling the foundation area with stone. Bids will be publicly opened and read in the PGC Division of Contracts and Procurement, 2001 Elmerton Avenue, Harrisburg, PA 17110-9797, on Wednesday, April 10, 2019 at 2:00 PM.

When bidding, amount bid should be in dollars and cents-----no fractions of a cent will be accepted.

Questions concerning project specifications and requirements should be directed to Foster Schaffer in the PGC-Engineering Division at 717-787-9620. Any questions concerning completion of the electronic bid should be directed to PGC-Contracts and Procurement Division at 717-787-6594.

Bidders should visit the site to ascertain the pertinent conditions such as access, site contours, proximity of utilities, structural characteristics of the building and vegetation in the work area. Contact Ryan Gildea, PGC NE Group 4 Land Manager at 570-675-1143 for directions to the site and to make arrangements to visit the site. This phone number is for the PGC Northeast Regional office in Dallas. Dispatchers at the regional office will relay messages to Mr. Gildea. Interested bidders can also call Dave Brundage at 570-894-0554. Mr. Brundage is the PGC Monroe County Foreman. The phone number is for the crew building on State Game Lands #127. The personnel that work in this building are frequently out in the field so please leave a message. A location map is included on the drawing. The building to be demolished is located off a PGC stone access road. The road is behind a locked gate but the site is accessible by walking from a PGC parking area along a public road. Prior permission to visit the site is not required; however, the building is locked and arrangements will have to be made to enter the building if interested. Interested bidders should contact the PGC Land Manager or Foreman at the phone numbers listed above to make these arrangements.

Attached to the electronic project listing are Terms and Conditions of Project, Conditions for Construction Contracts and Technical Specifications (Sections 1 through 6). One drawing titled "Demolition of Camelback radio Building" is attached also. These enclosures are part of

the bid. All bids must be submitted electronically using the SRM system. Bids must be received by 2:00PM on April 10, 2019. A bid guarantee or bond is not required.

The Commonwealth reserves the right to reject any and all bids, to waive technical defects in bids and to accept or reject any part of the bid deemed in the best interests of the Commonwealth. Except as otherwise provided by law, award will be made to the lowest responsible and responsive bidder. A Purchase Order will be generated at the time of award without further input from the successful bidder. Awarded vendor will be sent a copy of this document and no work will be authorized until the vendor is in receipt of the Purchase Order.

All vendors who conduct business with the Pennsylvania Game Commission must have a Vendor No. assigned to them in order to receive payment from the Commonwealth.
