The Pennsylvania Game Commission (PGC) is soliciting electronic bids for the construction of a deer dumpster pad and ramp at State Game Lands #188. The scope of the project includes clearing and grubbing the site, grading the site and placement of precast concrete blocks, AASHTO #3 stone and #2A coarse aggregate. Bids will be publicly opened and read in the Division of Contracts and Procurement, 2001 Elmerton Avenue, Harrisburg, PA 17110-9797, on Wednesday, October 30, 2019 at 2:00 PM.

When bidding, amount bid should be in dollars and cents-----no fractions of a cent will be accepted.

Questions concerning project specifications and requirements should be directed to Foster Schaffer at 717-787-9620. Any questions concerning completion of the electronic bid should be directed to the PGC Procurement Section at 717-787-6594.

Bidders should visit the site to ascertain the pertinent conditions such as access, site contours and vegetation in the work area. Contact Doug Barrick, PGC-SC Region Group 3 Land Manger at 814-643-1831 to get directions. This is the phone number for the PGC-South Central regional Office in Huntingdon. Dispatchers at the regional office will relay messages to Mr. Barrick. Bidders may also contact Shannon VanHorn, PGC-Snyder County Foreman at 570-658-6545. This is the phone number for the maintenance building in Beavertown. Personnel that work at this building are frequently out in the field so please leave a message. The project area is open to the public and prior permission is not required to visit the site.

Attached to the project listing in electronic format are Terms and Conditions of Project, Conditions for Construction Contracts and Technical Specifications (Sections 1 through 6). One drawing titled "Deer Dumpster Pad and Ramp" is also attached. All bids must be submitted electronically using the SRM system and must be submitted by 2:00 PM on Wednesday, October 30, 2019. A bid guarantee or bond is required.

The Commonwealth reserves the right to reject any and all bids, to waive technical defects in bids and to accept or reject any part of the bid deemed in the best interests of the Commonwealth. Except as otherwise provided by law, award will be made to the lowest responsible and responsive bidder, and all bidders will be advised of the bid results. A Purchase Order will be generated at the time of award without further input from the successful bidder.

Awarded vendor will be sent a copy of this document and no work will be authorized until the vendor is in receipt of the Purchase Order.

All vendors who conduct business with the Pennsylvania Game Commission must have a Vendor No. assigned to them in order to receive payment from the Commonwealth.
