The Pennsylvania Game Commission (PGC) is soliciting electronic bids for improvements to Connelly Run Road on State Game Lands (SGL) #86. The scope of the project includes widening and grading the road, excavation for a new southern approach to the existing bridge, installation of drainage pipes with stone bedding, construction of the road surface with stone from an on-site borrow area and site stabilization. Bids will be publicly opened and read in the Division of Contracts and Procurement, 2001 Elmerton Avenue, Harrisburg, PA 17110-9797, on Wednesday, April 15, 2020 at 2:00 PM.

**When bidding, amount bid should be in dollars and cents-----no fractions of a cent will be accepted.**

Bidders should visit the site to ascertain the pertinent conditions such as existing road surface conditions, drainage patterns and other working conditions. An optional one-time only tour of the work site has been scheduled for Monday, April 6, 2020 at 10:00AM. Refer to Section III of the specifications for details of the site tour.

Attached to the project listing in electronic format are Project Specifications. Location maps/site plans and the prevailing wage determination for the project are attached to the specifications. All bids must be submitted electronically using the SRM system and must be submitted by 2:00PM on April 15, 2020. A bid guarantee or bond is not required.

The Commonwealth reserves the right to reject any and all bids, to waive technical defects in bids and to accept or reject any part of the bid deemed in the best interests of the Commonwealth. Except as otherwise provided by law, award will be made to the lowest responsible and responsive bidder, and all bidders will be advised of the bid results. A Purchase Order will be generated at the time of award without further input from the successful bidder. Awarded vendor will be sent a copy of this document and no work will be authorized until the vendor is in receipt of the Purchase Order.

All vendors who conduct business with the Pennsylvania Game Commission must have a Vendor No. assigned to them in order to receive payment from the Commonwealth.
