TECHNICAL SPECIFICATIONS FOR ROAD CONSTRUCTION PROJECT ON SGL 86 WARREN COUNTY

Connelly Run Road Project

1.1-SCOPE

This work involves improving approximately 16,800 feet of road in Deerfield Township, Warren County. The contractor is required to widen an existing road (16,800') to a minimum 16' road footprint (ditch to ditch) with a 12-foot running surface, establish ditch lines leading into cutouts or culverts, install culverts at designated locations, apply gameland pit stone to the road surface, crown the stoned road to drain all water into the ditches, and roll with a vibratory road roller to further compact and shape the road.

The contractor will supply and install forty-one (41) 18" diameter x 30-foot and one (1) 18" diameter by 40-foot aluminized Type II steel culverts. Contractor must supply 840 tons of 2A aggregate to use in the installation of culverts. Minimum of 20 tons of 2A aggregate must be used for each culvert installation.

The contractor will be required to excavate a section of road bank approximately 200 feet long by 20 feet wide in order to better align the road with an existing bridge over Connelly Run. The existing bridge has a 45-ton weight limit and a 5-mph speed limit for fully loaded trucks.

1.2 PROCEDURE

- I. The contractor will notify the PGC Assistant Regional Forester three days prior to beginning the project. The contractor may work at times other than the schedule of the PGC representative. Inspection of the project will occur during normal working hours.
- II. The contractor will be required to widen an existing road (16,800') to a minimum 16' road footprint (ditch to ditch) with a 12-foot running surface and establish ditch lines leading into cutouts or culverts. Ditches are to be a minimum of 1 foot deep and sloped 1:3. Road banks are to be sloped to a maximum of 1:1. Refer to the road cross section drawing.
- III. The contractor will be required to excavate a section of road bank approximately 200 feet long by 20 feet wide in order to better align the road with an existing bridge over Connelly Run. This is for the approach from the south. Refer to the bridge approach cut section drawing.
- IV. The contractor will supply and install forty-one (41) 18" diameter x 30-foot and one (1) 18" diameter by 40-foot aluminized Type II steel culverts. Contractor must supply 840 tons of 2A aggregate to use in the installation of culverts. Minimum of 20 tons of 2A aggregate must be used for each culvert installation. The new culverts must be set in a minimum of 4" of compacted 2A gravel. The 12-foot road surface directly over the culvert

must be a minimum of 12 inches deep of compacted 2A aggregate. The remaining 2A will be tapered into the existing road elevation on either side of the pipe. A backhoe or excavator will be required to install the culverts. Locations of the new culverts are shown on the attached map and are designated with red paint on trees near the sites.

- V. Following the culvert installations, the contractor must then apply stone from a gameland pit to the roadway to a depth of 1' for a width of 12' for a total linear distance of 16,800 feet. A total of 13,104 tons of stone will be required. Stone is available from a pit on the gameland. The operator must use a bulldozer to shape and grade the stone as it is applied. The crown on the roadway shall be 5 inches (or 6 percent). The operator must then use a vibratory road roller (minimum 10 tons) to further compact and shape the stone after application.
- VI. Immediately following road improvement work, any disturbed areas outside of the road surface must be seeded with wheat or oats at a rate of 60 lbs./acre and mulched with straw (40 bales/acre).

1.3-GENERAL REQUIREMENTS

- Damage to existing infrastructure will be repaired by the contractor. At conclusion of use any areas used for staging outside of the road foot print must be returned to original condition at the contractor's expense. The need for any repair will be determined by the Officer in Charge prior to the conclusion of the project.
- II. A copy of weigh slips will be provided to the Regional Forester for all stone delivered to the site.
- III. Gates are always to be kept closed and locked except when the contractor is present on the site.
- IV. Burning is not permitted and all trash and litter resulting from this project must be removed.
- V. Operator may contact Penn DOT District 1-0 office at 814-678-7085 for permitting and/or bonding information for any state roads to be used. For additional information go to <u>http://www.papostedroads.pa.gov/</u>.
- VI. No operations will be permitted the opening day and all Saturdays during spring turkey season, including the youth spring gobbler hunt. The contractor, employees, and sub-contractors may not hunt to, from, or at the job site when the work location is beyond a gated road that is closed to public traffic. The contractor may travel to and from the work location on <u>no-work</u> days to check on the condition of equipment.
- VII. Final inspection of the project will be conducted by the Assistant Regional Forester or designee. The contractor may be present at the final

inspection. Upon successful completion of the required work, payment will be released to the contractor.

- VIII. All work, including site cleanup, must be completed by the expiration date of the project.
- IX. The Pennsylvania Game Commission reserves the right to inspect/evaluate the equipment which will be used to complete the contract. If in the opinion of the Officer in Charge (OIC) the equipment is not adequate to meet the specifications of the contract, the contractor will have two options. One option is to secure and utilize other equipment acceptable to the OIC for the project. The second option is to decline the contract. If the contractor does not have adequate equipment to complete the project and does not obtain satisfactory equipment, the contract will be terminated. The decision of the Officer in Charge as it relates to proper equipment and its ability to complete the work will be final.
- X. Failure to meet and follow the terms and conditions of the project will be grounds to terminate the contract.
