The personnel that work out of this building are frequently out in the field; please leave a message if there is no answer. A location map is included on the drawing. The building to be demolished are located off a public road. This area is open to inspection. Prior permission to view the site is not required. Interested bidders should contact the PGC Land Manager or Foreman at the phone numbers listed above to get specific directions.
