When bidding, bid amount should be in dollars and cents----no fractions of a cent will be accepted. The HVAC, Electric and Plumbing line items are to be considered separate bids and awarded as such. See Bid Notice for PGC-322-19-02. All line items in this contract will be awarded to the "General" Contractor with the overall low bid.
