Questions and Answers

- 1. Q. Who is the current incumbent for the contract?
 - A. There are multiple contracts please see the link below provided: select Description in the "search by" drop down menu, Enter the words "Truck Transport" and select the "Search" button. Select any blue square with a white "O" in it. This opens the Contract Overview for all Truck Transport contracts.

- 2. Q. May I please get a bid tabulation from the last award of this contract?
 - A. All the information on the previous solicitations is contained in the response to question 1 above.
- 3. Q. May I please get a copy of the most recent fuel invoice and supporting Bill of Lading for each location?
 - A. All information regarding delivery locations is contained in the solicitation.
- 4. Q. Please provide a breakdown of the specific fuel type for each site.
 - A. That information is contained in "Exhibit 1 Fuel Tank Locations Fuels Truck Transport 2022"

- 5. Q. Please provide a breakdown of the estimated volumes for each fuel type per site?
 - A. That information is contained in "Exhibit 1 Fuel Tank Locations Fuels Truck Transport 2022"
- 6. Q. When is the expected award date of the contract?
 - A. As soon after the bid opening the responsive and responsible low bidders can be identified.
- 7. Q. Please provide a breakdown of months during year that each diesel fuel type will be used by region.
 - A. That breakdown is agency location dependent, COSTARS participant dependent and weather/temperature dependent and not available.
- 8. Q. Is the annual fuel volume out of Elizabethville, PA (District 8, Line 39 on Exhibit 1) the same as the annual fuel volume out of Harrisburg, PA (District 8, Line 38 on Exhibit 1).
 - A. No. Line 39 indicates a different delivery location and tank size within the same PennDOT District.
- 9. Q. Can the county provide annual volumes and specific fuel types on the line items that state 'Data Included in Values Above'?
 - A. The requested information is not available.
- 10. Q. What months will need winter additives on the diesel fuel types?
 - A. That information is agency and location dependent, COSTARS participant dependent and weather/temperature dependent and not available.




