The personnel that operate out of this building are frequently in the field; please leave a message and your call will be returned. The project area is not open to vehicles. The gates at both ends of the road are locked. Permission is not required to visit the site; however, we recommend contacting Mr. Sitlinger for status of road conditions before going to the site.

Attached to the project listing in electronic format are Terms and Conditions of Project, Conditions for Construction Contracts and Technical Specifications (Sections 1 through 13). Three drawings titled "Railroad Grade Road Project (Phase 2)" are also attached. All bids must be submitted electronically using the SRM system and must be submitted by 2:00PM on January 18, 2023. A bid guarantee or bond is not required.
