- SCOPE: The Department of Corrections (PA DOC) is issuing this Invitation for a Bid (IFB) to procure 25 Sons of Liberty M-4 (M4-M89) 5.56 Mil Spec Rifles. The firearm specifications and quantities are set forth in these Specifications as are those for all related products and services. This is a no substitute bid for the firearms and listed accessories. The only firearms that will be accepted for this bid are the Sons of Liberty M-4 (M4-M89) 5.56 Mil Spec Rifle. The items listed under Training Equipment and Accessories are required. The Unit price for each new firearm should include the firearm as specified.
- METHOD OF AWARD: As a result of this IFB, the Commonwealth will award a Purchase Order to the lowest responsive and responsible bidder. (Bidder must submit all required documentation in order to qualify) The Bidder must bid on all tabs listed in the technical submittal of this IFB (Lots 2, 3, 4, and 5) together. Bids on one tab, without bids on the other listed tabs, will not be considered.

3. **DELIVERY LOCATION:** The firearms shall be delivered fully factory assembled and duty-ready. The awarded bidder shall provide weapon serial numbers prior to shipment to the PA DOC contact person listed below. The firearms, all training, equipment and accessories must be delivered within 180 days after being awarded the Bid. The awarded bidder shall contact the PA DOC contact person no later than seven calendar days prior to delivery in order to coordinate the delivery of the items. Upon receipt of all the products listed in this IFB, the PA DOC will have 30 days to coordinate the transfer of the trade in items to the awarded Bidder. - a. <u>Cost/Prices</u> The cost proposal submitted by the selected Offeror will be incorporated into any resulting Contract and the selected Offeror will be required to provide the awarded item(s) at the price quoted in its proposal. All Offeror's pricing for the selected tabs must be provided on the **Cost Submittal**. All items for tab 1 must be completed in full and pricing must be provided for all items on each tab. Detailed instructions for completing the Cost Submittal are provided on the Instructions Tab of the document.
- b. <u>Licenses</u> Offerors must have all federal, Pennsylvania Firearm's Licenses, and authorizations to sell the required weapons. A copy of these documents must be submitted with your proposal. In addition, all Offerors must be a Sons of Liberty dealer/distributor authorized to sell to Pennsylvania Law Enforcement. A copy of your authorization to sell in Pennsylvania must be submitted with your proposal.
- c. <u>New Equipment Unless specified</u>, all products offered by the Offeror must be new. A "new" product is one that will be used first by the Commonwealth after it is manufactured or produced. Unless otherwise specified used, remanufactured, or reconditioned products are not acceptable.
- **d.** <u>Post Submission Descriptive Literature.</u> -The Commonwealth may during its evaluation of the proposed product(s), require the Offeror to submit cuts, illustrations, drawings, prints, test data sheets, specifications sheets and brochures which detail construction features, design components, materials used, applicable dimensions and any other pertinent information which the Issuing Office may require in order to evaluate the product(s) offered. The required information must be submitted with in two (2) business days after notification from the Issuing Office. Failure to submit the required information prior to the expiration of the second business day after notification shall result in the rejection of the proposal as non-responsive.
