The Pennsylvania Emergency Management Agency is procuring Automatic License Plate Readers.

The Automatic License Plate Readers (ALPRS) will be located on patrol vehicles of the selected police departments throughout the region. The purpose of the device is to enhance counter-terrorism capabilities for law enforcement agencies in the region by automatically and without human control locate, focus on and photograph license plates and vehicles that come into range of the device. The data will automatically convert digital photographs of scanned license plates into an electronic text document that is capable of comparing scanned license plate text data with data files for vehicles on BOLO (list programmed into the devices electronic memory and notifies the police). A regional program management team provides IT/Network support for regional capture and sharing of information. System must be compatible/interoperable with system listed below.

quality, and performance equivalence as to meet the standard of quality of products other than the referenced product shall: a) furnish complete identification in its Bid of the product it is offering by trade name, brand and/or model number; b) furnish descriptive literature and data with respect to the substitute product it proposes to furnish; and c) indicate any known specifications deviations from the referenced product.

If substituting from the original equipment requested, please provide certification that the product(s) you are quoting are compliant with the rules/regulations of the National Defense Authorization Act.

Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the People's Republic of China.
