SCOPE OF WORK

The Commonwealth of Pennsylvania, Department of Corrections, SCI Dallas, requires a new Supervisory Control and Data Acquisition (SCADA) system computer, software licenses, engineering services and on site startup, commissioning and training in accordance with the Statement of Work.

CONTRACT TASKS

The Contractor will provide services detailed below.

New Supervisory Control and Data Acquisition (SCADA) system computer, software licenses, engineering services and on site startup, commissioning and training.

Hardware Included:

- a. Pentium Dual-Core Dell Computer that includes:
 - i. 16.0 Gigabytes of RAM
 - ii. 500 GB hard disk drive
 - iii. CDRW/DVD-ROM Disk Drive
 - iv. Windows Professional Operating System
 - v. MS Office Professional
 - vi. Norton Antivirus

SCADA Software Included:

- a. Rockwell Software FactoryTalk View Studio Enterprise (SE) Development Package
- b. FactoryTalk View Studio Enterprise (SE) Station

Engineering and Labor to Include:

- a. Programming – Upgrading to FTView SE package to the latest version
- b. Code and alarm programming for customer-requested drum screen control changes

Field Services Included:

- a. One (1) Programming Engineer, one (1) trip, four (4) days on site
- b. On site installation and set up of new SCADA computer
- c. On site start up, commissioning, testing of new SCADA computer
- d. On site training of the new SCADA application

Warranty:

All parts to be free from defective material and workmanship for a period of one (1) year after startup or eighteen (18) months after shipment, whichever comes first, and to furnish to the Owner replacements for any such items found to be defective within that period.

The Contractor may terminate this agreement upon sixty (60) days written notice to the Business Manager at the State Correctional Institution at Dallas. The Commonwealth may terminate this contract for its convenience or lack of an appropriation of funds. Inadequate performance will be grounds for immediate termination.
