II. CONTRACT TASKS

- Titanium UDL-synthetic roofing underlayment
- GAF/ELK, Timberline Prestique, 30yrs architectural shingles, Mission Brown color
- Alaskan Yellow Cedar fascia
- Nail & hardware package
- IBC 2006 compliant
- Designed for 40lbs psf snow load & standard 100mph wind load.
- Kit must include sealed and stamped engineered drawings.

Bid price to include all shipping, transportation, and any other associated charges for delivery. Supplied materials are subject to the satisfaction and approval of the Department.

IV. DELIVERY PERIOD

Delivery will commence after receipt of purchase order and will terminate December 1, 2023.

V. BID AWARD

The bidder will complete and return the following for award of the bid:

- B. A properly executed Reciprocal Limitations Act form that lists the state of manufacture for any supplies procured.
- C. A properly executed Worker Protection and Investment Certification Form. Bids will be awarded based on a total sum.

NOTE: The Department will only accept out to two (2) decimal points when entering your 'Unit Price' bid.

VI. PAYMENT TERMS

Payment shall be made on a reimbursement basis following delivery and final acceptance of approved product.
