The Pennsylvania Game Commission (PGC) is soliciting electronic bids for renovating an existing shooting range complex on State Game Lands (SGL) #176. The scope of the project includes construction of shooting station shelters, concrete sidewalks, target stations and a chain link fence. Bids will be opened electronically in the Division of Contracts and Procurement, 2001 Elmerton Avenue, Harrisburg, PA 17110-9797, on Wednesday, October 18, 2023 at 2:00 PM.

When bidding, amount bid should be in dollars and cents-----no fractions of a cent will be accepted.

Questions concerning project specifications and requirements should be directed to Foster Schaffer, PGC-Engineering Division at 717-787-4250, ext. 73322. Any questions concerning completion of an electronic bid should be directed to PGC-Contracts & Procurement Section at 717-787-6594.

Bidders should visit the site to ascertain the pertinent conditions such as access, site contours, proximity of utilities, structural characteristics of the buildings and vegetation in the work area. Contact Eric Erdman, PGC North Central Region Group 4 Land Manager at 570-398-4744 to get directions and site information. This is the phone number for the Game Commission's regional office in Jersey Shore. The dispatchers at the regional office will relay messages to Mr. Erdman. You may also contact Russ Dubbs, PGC Centre County Foreman, at 814-342-6275. This phone number is for the PGC Centre County maintenance building outside Philipsburg. The personnel that operate out of this building are frequently in the field; please leave a message and your call will be returned. The project area is open to public travel. Permission is not required to visit the site; however, we recommend contacting Mr. Erdman or Mr. Dubbs for status of conditions before going to the site.

Attached to the project listing in electronic format are Terms and Conditions of Project, Conditions for Construction Contracts and Technical Specifications (Sections 1 through 20). Nine drawings titled "Scotia Range Complex Renovation Project, Phase 1" are also attached. All bids must be submitted electronically using the SRM system and must be submitted by 2:00PM on October 18, 2023. A bid guarantee or bond is not required.

The Commonwealth reserves the right to reject any and all bids, to waive technical defects in bids and to accept or reject any part of the bid deemed in the best interests of the

Commonwealth. Except as otherwise provided by law, award will be made to the lowest responsible and responsive bidder, and all bidders will be advised of the bid results. A Purchase Order will be generated at the time of award without further input from the successful bidder. Awarded vendor will be sent a copy of this document and no work will be authorized until the vendor is in receipt of the Purchase Order.

All vendors who conduct business with the Pennsylvania Game Commission must have a Vendor No. assigned to them in order to receive payment from the Commonwealth.
