The Issuing Office received the following questions regarding the above-referenced RFP and provides the following responses. |

Q.1. Is OGC-2018-10 only open to those firms who have been awarded contracts in the past as a result of OGC-2015-65 or OGC-2016-22?

A.1. OGC-2018-10 is not open to only firms who have been awarded contracts in the past as a result of OGC-2015-65 or OGC-2016-22. This RFP is open to anyone who is interested in bidding in.

Q.2. Would the solicitation #OGC-2018-10: General Litigation & Emergency Counsel include a potential contract for Securities Litigation and/or Portfolio Monitoring or will a separate RFP be issued at some point for those services?

A.2. This RFP does not specifically include a potential contract for Securities Litigation and/or Portfolio Monitoring. A separate RFP will be issued at some point for those services. With that being said, please note on page 25 of the RFP document, it lists the types of engagements envisioned as a result of this RFP and states, “but are in no way limited to.” This is because we simply cannot foresee the exact types of engagements that will result from these awards.

A couple of people reported having problems opening Appendices G, H and K. This issue should have been resolved, but if you continue to have problems opening Appendices G, H or K, please let me know and I will assist you with opening them

Please note that if you have an existing contract as a result of RFP OGC-2015-65, your contract is set to expire within the next year. If you would like to continue to be considered for this work, provided your firm is selected, you will need to respond to this new solicitation
