Data that may be examined during this engagement is hosted in a variety of manners. Some data is hosted by a third-party with whom PSERS contracts; some data is hosted by a software provider through a cloud-based system; and some data may be hosted locally.

- Are the primary applications that would be in scope developed in-house? Or are they purchased application software maintained by third parties?
 Most of the primary applications are third-party Software as a Solution (SaaS) products.
- Approximately how many employees are employed by PSERS?
 PSERS has an authorized complement of approximately 350 employees.



- How many physical locations does PSERS operate out of, including offices and data centers? PSERS Headquarters is in Harrisburg, Pennsylvania. PSERS also maintains member/employer services locations in six Field Offices located across Pennsylvania in Ebensburg, Franklin, Lock Haven, Pittsburgh, Scranton, and Warminster.
- Is there automated or system monitoring surrounding the Financial Reporting, Investment (DB Only), and DC Plan control areas, or is there primarily manual (human) reconciliations and monitoring to satisfy these objectives?
 Primarily manual reconciliations and monitoring are leveraged.
- Does the organization have a vendor management program in place to monitor and review vendors that are key to the services in scope?
 No. There is not a formal vendor management program in place currently; however, there are controls in place to monitor key vendors.
- Has an Information Security Risk Assessment been completed over the intended scope previously?
 No; while PSERS has completed Security Risk Assessments, an assessment on the intended scope of this engagement has not been completed.
