On Page 13, Part II, Section II-4 Tab 5-Prior Experience of the RFP-"For Lots 1, 2, 3, and 5, Offerors must identify any current contracting or subcontracting relationships that may result in a conflict of interest with the requirements of this RFP, including any contract, subcontract or other arrangement in which it or its proposed subcontractors provide IT planning or technical services for DHS enterprise systems.

On Page 25, Part IV, Section IV-1. Objectives. B. Specific of the RFP-"Further, for Lots 1, 2, 3, and 5 the Department will not select any Offeror or subcontractor to the Offeror for contract award if the Offeror or subcontractor provides IT planning or technical services for DHS enterprise systems. This preclusion is not applicable to Lot 4 Predictive Analysis."
