

**AMENDMENT NUMBER 1**

**TO**

**CONTRACT NO. 4400012448**

This Amendment No. 1 to Contract No. **4400012448** ("Contract") is by and between PA Advocates, Inc. ("Contractor") and the Commonwealth of Pennsylvania, acting through the Department of General Services ("DGS").

**WHEREAS**, the Contractor and DGS entered into the Contract by which for the provision of providing the Commonwealth with vocational rehabilitation beginning with contract execution and ending October 31, 2018;

**WHEREAS**, the Contractor and DGS exercised the option in Section V.3 of the Contract to extend the term of the Contract for up to three (3) months upon the same terms and conditions, extending the Contract end date to January 31, 2019;

**WHEREAS**, DGS is in the process of soliciting a new procurement for the services and requires additional time to complete the solicitation and allow the awarded new contracts to go through full approvals as a result from that process; and

**WHEREAS**, the Contractor and DGS desire to amend the Contract by extending the term of the contract and continuing to provide services upon the same terms and conditions for a five-month period, beginning February 1, 2019 and ending June 30, 2019, or until a new contract is in place, whichever occurs first.

**NOW THEREFORE**, for valuable mutual consideration and intending to be legally bound hereby, the parties agree as follows:

1. The term of the Contract is extended by five (5) months beginning February 1, 2019 and ending June 30, 2019, or until a new contract is in place, whichever occurs first.
2. Once the Contractor signs this Amendment Number 1, the Commonwealth's Contracting Officer will enter this document into the Commonwealth's SAP/SRM system to obtain the required Commonwealth approvals. This Amendment Number 1 will be effective following the final required Commonwealth approval.
3. Except as amended by this Amendment Number 1, all other terms and conditions of the Contract and Amendment Number 1 shall remain as originally written.
