

**Contract No. 4400015328**

**AMENDMENT**

This Amendment No. 2 is made by and between Change Healthcare Pharmacy Solutions, Inc. (formerly Goold Health Systems) (“Contractor”) and the Commonwealth of Pennsylvania, Department of Human Services (“DHS”).

**WHEREAS**, DHS issued Request for Proposals No. 08-14 (“RFP No. 08-14”) for the purpose of soliciting proposals from qualified entities to provide administrative services to DHS regarding the preferred drug list, drug rebates, and retrospective drug utilization review;

**WHEREAS**, Contractor submitted a proposal in response to RFP No. 08-14;

**WHEREAS**, DHS determined that the proposal submitted by the Contractor for RFP No. 08-14 was the most advantageous to DHS, taking into consideration all RFP evaluation factors;

**WHEREAS**, DHS entered into Contract No. 4400015328 (“Contract”) with Contractor to perform the services required by RFP No. 08-14 Preferred Drug List, Rebate, and Retrospective Drug Use Review Programs;

**WHEREAS**, the Department exercised its options to extend the Contract for two additional one-year periods; and

**WHEREAS**, as permitted by the Contract, the Department extended the Contract for an additional 90 days to May 31, 2021; and

**WHEREAS**, DHS and Contractor have identified the need to amend the Contract to extend the Contract term and to provide for pricing during this extension.

**NOW, THEREFORE**, in consideration of the foregoing, DHS and the Contractor, with the intention of being legally bound, agree to amend the Contract as follows:

1. The expiration date of the Contract is extended to September 30, 2023.
2. Effective June 1, 2021, the Contract is amended by deleting Section 10.340B Contract Services and Rider 1 Payment Provisions Section 1 Compensation/Types of Services Subsection b.(3) Compensation for 340B Services, both added by Amendment No. 1.
3. Attachment 3 Contractor’s Final Cost Proposal dated March 31, 2021, is amended by the addition of pricing for the period of June 1, 2021 through September 30, 2023 as follows:

4. The effective date of this Amendment will be set by DHS once the amendment has received all approvals required by Commonwealth contracting procedures. This Amendment shall continue in effect for the entire Contract term.

5. DHS, in its sole discretion, may extend this Contract on the same terms and conditions for two additional 6-month periods. DHS will notify Contractor of its election to exercise the renewal option in writing at least 30 days prior to the expiration of the then current term provided, that DHS's right to exercise any such renewal option shall not expire unless and until Contractor has given DHS written notice of DHS' failure to timely exercise its renewal option and has provided DHS with 10 days from DHS' receipt of the notice to cure the failure.
6. Except as expressly modified herein, all other terms and conditions of the Contract, as amended, remain in effect.
