Threat to public health, welfare, or safety

Identify the Threat:

The 5 year banking contract that we had expired in September along with the 90 extension period. While we tried to bid the contract we didn't have any bids. Solutran's Legal Department is currently not allowing them to bid on any FMNP/SFMNP contract for more than a one year period. Our bid was for 5 years. The requirement for the FMNP/SFMNP bank is more than to process checks they must also provide a daily file with the farmer identification number on each check processed. This federal requirement eliminates the majority of banks from bidding on this type of contract. Since this is a seasonal program with checks only processed from June – December banks aren't willing to hire people to do this work.

	Provide a brief exp of the need for the and/or service:	material	Each program year this program has over 600,000 checks processed. In order to be able to administer the Farmers Market Nutrition Program (FMNP) and Senior Farmers Market Nutrition Program(SFMNP) food assistance programs we need to have a processing bank with the ability to process the checks and provide the required farmer information from each check processed. The processing bank needs to be in place in January so that the checks for the program can be printed and shipped to the agencies for distribution by the start of the program. Bank account information must be printed on each check.			
	State the consequence procurement is no emergency basis:	t done on	If we don't have the processing bank in place in January we won't be able to print the checks, ship them and distribute them to using during the short season of this program. The time line for the program is according to federal regulation and corresponds with the growing season in Pennsylvania. (Checks can only be used to purchase Pennsylvania grown fresh fruits, vegetables and herbs) This would leave the over 300,000 recipients without this important source of food.
