Basis for the Emergency Purchase



Identify the Threat:

Highly pathogenic avian influenza (HPAI) is a more virulent and aggressive form of AI affecting mostly wild birds. H5/H7 HPAI viruses are the most dangerous to birds and can sometimes spread to poultry when the virus mutates and becomes more easily spread. The last notable outbreak of a dangerous HPAI strain in the US occurred in the winter of 2014-15 and greatly affected both the meat turkey and egg layer industry, decreasing US table egg production by 10%. This outbreak was contained to a few states – mostly Minnesota and Iowa in the Midwest – but this year a HPAI H5N1 strain, spread by wild birds, is popping up in states all over the country, including major commercial outbreaks in Maryland and Delaware near the PA border. Control zones for surveillance from the MD/DE outbreaks actually overlap into PA, so while the strain has not yet been detected here, it is very close and already affecting PA producers due to movement restrictions imposed within control zones.

Disposal of infected animal waste at the anaerobic digestor from infected Chester County Farms

State the consequence if the procurement is not done on emergency basis:

The goal when responding to a HPAI detection in poultry, especially commercial birds, is to depopulate the premises of all poultry within 24 hours of detection to reduce the spread of the virus to nearby farms. This is especially crucial in PA's high density poultry areas like Lancaster County, which is the most densely populated county for egg production in the country. If we cannot respond quickly to an outbreak with the large-scale resources needed – some of these farms have bird numbers in the millions – we risk the outbreak spreading quickly and unnecessarily to nearby premises and creating a much wider problem that will be exponentially more difficult and expensive to address as the spread occurs. Due to the wide spread of this year's HPAI outbreak in the US, USDA resources are severely strained, increasing the importance of the commonwealth procurement process due to the risk of USDA resources not being deployed either in a timely manner or at all. Many states affected have to explore contingencies where USDA resources are either slow to develop or that may never arrive due to more urgent demands in other states.
