Identify the Threat:

In total four houses have been confirmed to be affected by stray gas in the immediate neighborhood, with three houses having indoor ambient detectable combustible gas readings ranging from 0.006 to 0.5540% gas by volume. Two of the three residences with the highest ambient readings have been evacuated from their homes by PNG and both the natural gas and electricity supplies have been shut off to their homes. Elevated readings have been identified in two water supply well headspaces in the immediate area.

	Provide a brief exp of the need for the and/or service: State the consequ procurement is no emergency basis:	ence if the t done on	Stray gas has remained persistent in soils, water supplies and homes since investigation started on 4/5/2024. It is expected that the unpermitted gas well (Sunnyhill 1) is the source of stray gas in this immediate area. The gas well is obstructed by earth, wood and gravel plugs approximately 6ft. below ground surface. Clearing out the well and venting it to the atmosphere will provide a preferential pathway for the gas to follow in attempts to eliminate the gas entering the shallow formations and soils, water supplies and homes. Allowing stray gas to persist at current levels threatens the safety, health and well-being of occupants within homes around 321, 322, 313 Thompson Run Rd. and 99 Sunnyhill Dr., Pittsburgh, PA 15237 in Ross Twp., Allegheny County
