The investigation appears to be winding down and moving into a compliance monitoring phase. At this point in time, Mr. Smith will review the Department's protocols relating to the treatment of mentally ill offenders and the implementation thereof and make recommendations to assist the DOC in housing and treating mentally ill offenders in compliance with the constitutions and laws of the United States and Pennsylvania. At this point it would be impractical to bring in another consultant to provide these services.						
Why are those circumstances outside of the control of Agency?			Mr. Smith's services are necessary to ensure that the DOC is in compliance with the Department of Justice findings and at this point it would be almost impossible to bring in another expert. Replacing Mr. Smith would require that a new vendor learn the history of the investigation and the ensuing negotiation and policy changes. The time frame for these services does not provide sufficient time for this to occur. Mr. Smith had been providing services in conjunction with the Elliot Greenleaf law firm. The DOC is no longer using outside counsel for this case, therefore, it is necessary to contract directly with Mr. Smith.
