## 1. PURPOSE/STATEMENT OF WORK:

The Department of General Services, on behalf of the Pennsylvania Game Commission, is issuing Invitation for Bid (IFB) 6100065070 for the purchase and delivery of one (1) 2027 Tri-Axle Dump Truck with Dump Bed, in accordance with the requirements outlined in Bid Specification Section.

## 2. ELIGIBLE BIDDERS:

1. Must be an **Authorized/Franchised dealer** for the vehicles offered in **Pennsylvania**
2. Must hold a valid Pennsylvania Dealer License

All bidders must be authorized new vehicle dealers for the manufacturer(s) they represent. Bidders shall submit OEM authorization on official manufacturer letterhead, dated within six (6) months of the bid due date.

Suppliers are advised that licensing requirements are governed by Act No. 84 of 1983, commonly referred to as the Board of Vehicles Act.

All vehicles provided under this contract must be manufactured in North America, defined as the United States, Canada, or Mexico. To qualify, the majority of the vehicle's principal components must be assembled in a North American assembly plant. Contractors must be able to provide proof of compliance with these requirements in accordance with the Motor Vehicle Procurement Act (62 Pa. C.S. §§ 3731–3736).

## 3. BIDDING INSTRUCTIONS:

The following documentation must be completed and submitted with the bid. Failure to submit the documentation listed below will result in the bid being rejected.

- A. OEM Letters (if applicable)- Bidders who are not a manufacturer must submit a letter from the manufacturer(s) stating that the bidder is authorized to sell the product(s) in the Commonwealth of Pennsylvania.
- B. Lobbying Certifications and Disclosure, BOP-1307- This certification is a material representation of fact upon which reliance was placed when this transaction was made or entered into. Submission of this certification is a prerequisite for making or entering into this transaction imposed under *Section 1352, Title 31, U. S. Code*. Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than **\$100,000** for such failure.
- C. Reciprocal Limitations Act, GSPUR-89- Reciprocal Limitations Act (GSPUR-89): See Section II.4 II-IFB-017.1b Reciprocal Limitations Act – Electronic Submittal (February 2007) of the Terms and Conditions for details and requirements regarding this Act. All bidders must complete and return the Reciprocal Limitations Act Requirements Form, which is attached hereto and made part of this IFB. The completed and signed GSPUR-89 form shall be submitted with the bid response.
- D. Iran Free Certification and Disclosure-Prior to entering a contract worth at least \$1,000,000 or more with a Commonwealth entity, a bidder must: a) certify it is not on the current list of persons engaged in investment activities in Iran created by the Pennsylvania Department of General Services (“DGS”) pursuant to Section 3503 of the Procurement Code and is eligible to contract with the Commonwealth under Sections 3501-3506 of the Procurement Code; or b) demonstrate it has received an exception from the certification requirement for that solicitation or contract pursuant to Section 3503(e). All bidders must complete and return the Iran Free Procurement Certification form, which is attached hereto and made part of this IFB. The completed and signed Iran Free Procurement Certification form shall be submitted with the bid response.
- E. Worker Protection Act, BOP-2201- Pursuant to Executive Order 2021-06, Worker Protection and Investment (October 21, 2021), the Commonwealth is responsible for ensuring that every Pennsylvania worker has a safe and healthy work environment, and the protections afforded them through labor laws. To that end, contractors and grantees of the Commonwealth must certify that they are in compliance with all applicable Pennsylvania state labor and workforce safety laws. Such certification shall be made through the Worker Protection and Investment Certification Form (BOP-2201) (Appendix C). The completed and signed Worker Protection Certification Form shall be submitted with the bid response.
- F. Pennsylvania Dealer License. (For Vehicle Bids Only)

G. A **Letter of Authorization** or **Franchised Dealer Agreement** from the vehicle manufacturer, confirming that the bidder is an authorized dealer for the vehicles offered to the Commonwealth, is required for all vehicle bids. The letter of authorization must be **dated within the last six months**.

**4. METHOD OF AWARD:**

It is the intent of the Commonwealth to make a single award of item(s) listed in the IFB to the lowest responsive and responsible bidder. The Commonwealth reserves the right to award by line item if it determines that it is in the best interest of the Commonwealth to do so.

**5. PO TERM:**

The Commonwealth shall put forth reasonable efforts to make payment by the required payment date. The required payment date is: (a) the date on which payment is due under the terms of the Contract; (b) thirty (30) days after a proper invoice actually is received at the "Bill To" address if a date on which payment is due is not specified in the Contract (a "proper" invoice is not received until the Commonwealth accepts the service as satisfactorily performed); or (c) the payment date specified on the invoice if later than the dates established by (a) and (b) above. Payment may be delayed if the payment amount on an invoice is not based upon the price(s) as stated in the Contract.

**6. TARIFFS AND ADDITIONAL SURCHARGES:**

Under no circumstances may the supplier include or charge tariffs, surcharges, or any additional fee beyond the bid price. Any such charges listed will be disregarded by the Commonwealth and will not be considered part of the evaluated or payable amount.

**7. SHIPPING AND DELIVERY REQUIREMENTS:**

Please refer to PCID 1067 for the delivery address and delivery procedures. Suppliers are required to call at least 48 hours in advance to schedule delivery.

**8. FREIGHT:**

All vehicle(s) shall be delivered F.O.B. Destination. The Contractor agrees to bear the risk of loss, injury, or destruction of the vehicle(s) ordered prior to the receipt of the vehicle(s) by the Commonwealth. Such loss, injury, or destruction shall not release the Contractor from any contractual obligations. Except as otherwise provided in this contract, all vehicle(s) must be delivered within the time period specified in the Contract. Time is of the essence and, in addition to any other remedies, the Contract is subject to termination for failure to deliver as specified.

**9. STANDARD WARRANTY:**

The price shall include the standard manufacturer's warranty for all products provided if that warranty is greater than warranty required in the attached Terms and Conditions or PCID-1067. The warranty period shall be from date of delivery of equipment.
