To All Suppliers:

The Commonwealth of Pennsylvania defines a solicitation “Addendum” as an addition to or amendment of the original terms, conditions, specifications, or instructions of a procurement solicitation (e.g., Invitation for Bids or Request for Proposals).

List any and all changes:

Vendor questions and answers as follows:

- Brief description of student duties? Students are assigned to a full time tactical team.
- Participant level of experience? Time assigned to tactical team ranges from 6 months to 13 years.
- Will participants consist of organic or mixed units? Students will only be members assigned to the tactical team.
- Will the same students take all three modules? Yes.
- Should training modules be in one training handbook or three separate training handbooks? Training materials should be provided in three separate handbooks.
- Who provides the training facilities? PSP will provide the training venues.
 1. Classroom – Yes
 2. Outdoor Range – Yes
 3. Shoothouse and multiple floor building – Yes
 4. Medic on site – Yes
 5. Range master / support – No
 6. Targets – Provided by vendor based on course curriculum
- Who provides vehicles? PSP will provide the necessary vehicles for any training scenarios.
- Will role players be required, if so, who will provide? Role players should be utilized for Close Quarter Battle and SUT/Linear Assault courses and will be provided by PSP.
- Who provides carbines(magazines, sling), handguns and holster/pouches for trainees? Students will be fully equipped with team issued gear.
- Will testing and evaluation be up to the training provider or is there a state regulation to follow? Testing and evaluation is up to the training provider. There are no specific state regulations to follow, however, teaching concepts need to be evaluated by PSP prior to course to ensure the curriculum follows current TTP's.
- Linear mentioned. Will tubular (bus) linear assault be included? A bus will be provided for the linear assault course.
- Force-on-force. Who supplies non-lethal ammunition, conversion kits, and PPE? PSP will provide all ammunition, conversion kits, and PPE for its members.

- Who provides simulation/UTM weapons and safety equipment? PSP will provide the necessary weapons and safety equipment.
- What is the instructor/student ratio required, if any? Minimum instructor to student ratio is 1:12. There will be 24 students in each course, so no less than two instructors.
