I-1. Statement of the Project.

The Pennsylvania State Police (PSP), Bureau of Criminal Investigation (BCI) is issuing this Invitation for Bid (IFB) to procure a First Responder Camera System for the 31' PSP Safeboat vessel. These requirements and quantities are set forth in these specifications as for all related products and services. This is a no substitute solicitation.

I-2. Specification and Quantity.

B. Installation:

- Removal of all existing thermal camera hardware including wiring.
 - The State Police 31' Safeboat vessel currently utilizes a Gyrocam Dual Sensor camera system which is mounted on the roof of the vessel. A color display monitor is mounted on the dash of the vessel in front of the passenger seat to view video imagery captured by the camera. The camera system is equipped with a digital video recorder (DVR) and external hard drive to capture and retain footage.
- Removal of all existing standalone monitor including hardware.
- Removal of L3 AIS, including wiring.
- Fabrication and installation of patch panel to cover removed AIS display.
- Installation of FLIR M400XR thermal camera system, including PoE switch & Raymarine RNS8 network switch.
- Integration of FLIR M400XR thermal camera system onboard vessel with existing navigation system.
- Installation and integration of Raymarine AIS5000 encrypted AIS.
- Installation and setup of Barnacle Black System with existing sensors and cameras, includes peripheral encoders.

• Commissioning and testing of all installed equipment to ensure proper functionality. Must be signed off on by PSP.

C. Training:

- 1 day on the water and classroom training with end users on operation and maintenance of FLIR & Raymarine electronics.
- Training documents must be provided electronically or hard copy upon request.

I-3. Warranty.

- 3-year parts and onboard labor warranty.
 - After the equipment is received, the serial numbers of all equipment and the boat's Hull Identification Number must be entered into FLIR's database to cover the warranty.
 - Should the installer not be able to repair the items for whatever reason, PSP would have the repair conducted at any of the 221 FLIR certified dealers within the United States.

I-4. Manufacturer Authorization.

• If the offeror submitting a response to this IFB is not the original equipment manufacturer (OEM) of the equipment being provided, the Offeror must submit a Manufacturers Authorization Letter which clearly states the Offeror is authorized to provide and install the OEM's equipment. The Manufacturer Authorization Letter must reference "IFB 6100063462 – PSP BCI First Responder Camera System".
