Addition to the Terms and Conditions Section V.28 CONTRACT-022.1 Force Majeure (Oct 2006) has been requested:

"(Offeror/awarded supplier) shall not be responsible to Consignor for any theft or loss of any Vehicle and for any damage to a Vehicle that takes place while such Vehicle is in (Offeror/awarded supplier) possession, in whole or in part, as a direct or indirect result of (i) any act or omission on the part of Consignor or any of its employees or representatives; (ii) any act of God (including any weather-related event) or any other Force Majeure Event; and (iii) any design defect or mechanical failure affecting a Vehicle (unless such defect or failure was caused by (Offeror/awarded supplier))."

#### Answers:

The request to modify the Terms and Conditions would create Non-Standard Terms and Conditions for incidences/occurrences that are covered in the Insurance section of the Statement of Work (SOW) for "Garage keeper's liability insurance". The Insurance requirements and the Terms and Conditions will not be altered.




