Ouestions and Answers

Q1: Would this be a tax-exempt purchase?

A1: Yes, this is a tax-exempt purchase. See Terms and Conditions V.23 CONTRACT-017.1 Taxes (Dec 5 2006), which is attached to the IFB.

Q2: When would we know if we received the approval?

A2: A bid tabulation is posted to eMarketplace showing all submitted bidders and dollar amounts. This is not an award, but a notification showing the results. An award is typically made within 3 weeks of the IFB close date.

Q3: Does all equipment's get shipped at one location?

A3: Yes, all equipment is to be shipped to one location, Philadelphia, PA 19123.

Q4: When will the bid be awarded once the bidding date closes on March 22?

A4: A fully executed purchase order is typically awarded within 2-3 weeks of bid closing but can take up to 60 days. By law, a contract must be awarded within 60 days of the bid opening. The 60-day time limit may be extended by mutual written consent of the contracting officer and the lowest responsible and responsive bidder. A5: All bids must be submitted electronically through the IFB. Quotes submitted via hardcopy or email will not be accepted.

A6: Line 6, added an alternate pat number to be quoted in the event a bidder does not have access to provide the part number being discontinued.
